The World Health Organization Emphasizes Mental Health as Key to Overall Health

Key Messages

- ⇒ Mental health is essential to everyone's overall health and well being, and mental illnesses are common and treatable.
- ⇒ Eating healthy foods, managing stress, exercising, and getting enough sleep can go a long way in making you both physically and mentally healthy.
- ⇒ Getting the appropriate amount of exercise benefits nearly all aspects of a person's health. Not only does exercise help control weight, it also improves mental health and increases your chances of living longer and healthier.
- ⇒ Recent research is connecting your gut health with your mental health. So, when it comes to diet and nutrition, it's all about finding the right balance of nutrients to benefit mind and body.



Asotin County Community Services CRP for AbilityOne

The AbilityOne Program provides a wide range of employment opportunities to two target groups, people who are blind and those with a range of significant disabilities who face the highest barriers to achieving competitive employment on their own. They are employed by agencies of state government or, in the majority of cases, private, community-based organizations that operate as nonprofit agencies (often referred to as Community Rehabilitation Programs or "CRP's) including Asotin County Community Services. These organizations are qualified to do federal contract work through the AbilityOne Program by the U.S. AbilityOne Commission. Asotin County Community Services contracts with AbilityOne to provide custodial services on the levee, at the Corps headquarters in Clarkston and for the social security building in Lewiston. Through our AbilityOne contracts, ACCS employs temporary, permanent and seasonal employees with significant disabilities or blindness.

The AbilityOne Program's definition for a significant disability other than blindness is as follows: "a severe physical or mental impairment (a residual, limiting condition resulting from an injury, disease, or congenital defect) which so limits the person's functional capabilities (mobility, communication, self-care, self-direction, work tolerance or work skills) that the individual is unable to engage in normal competitive employment over an extended period of time."
